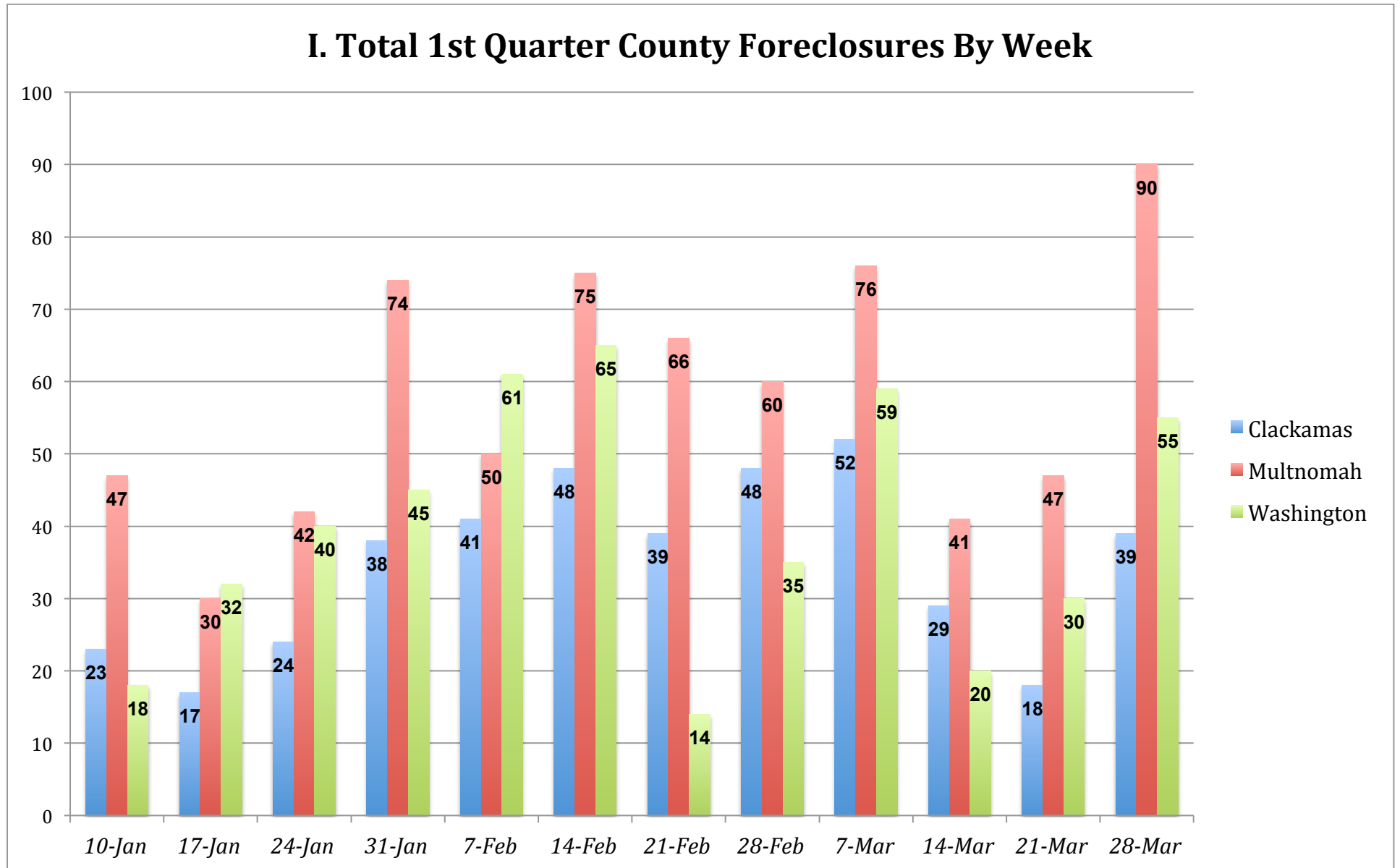


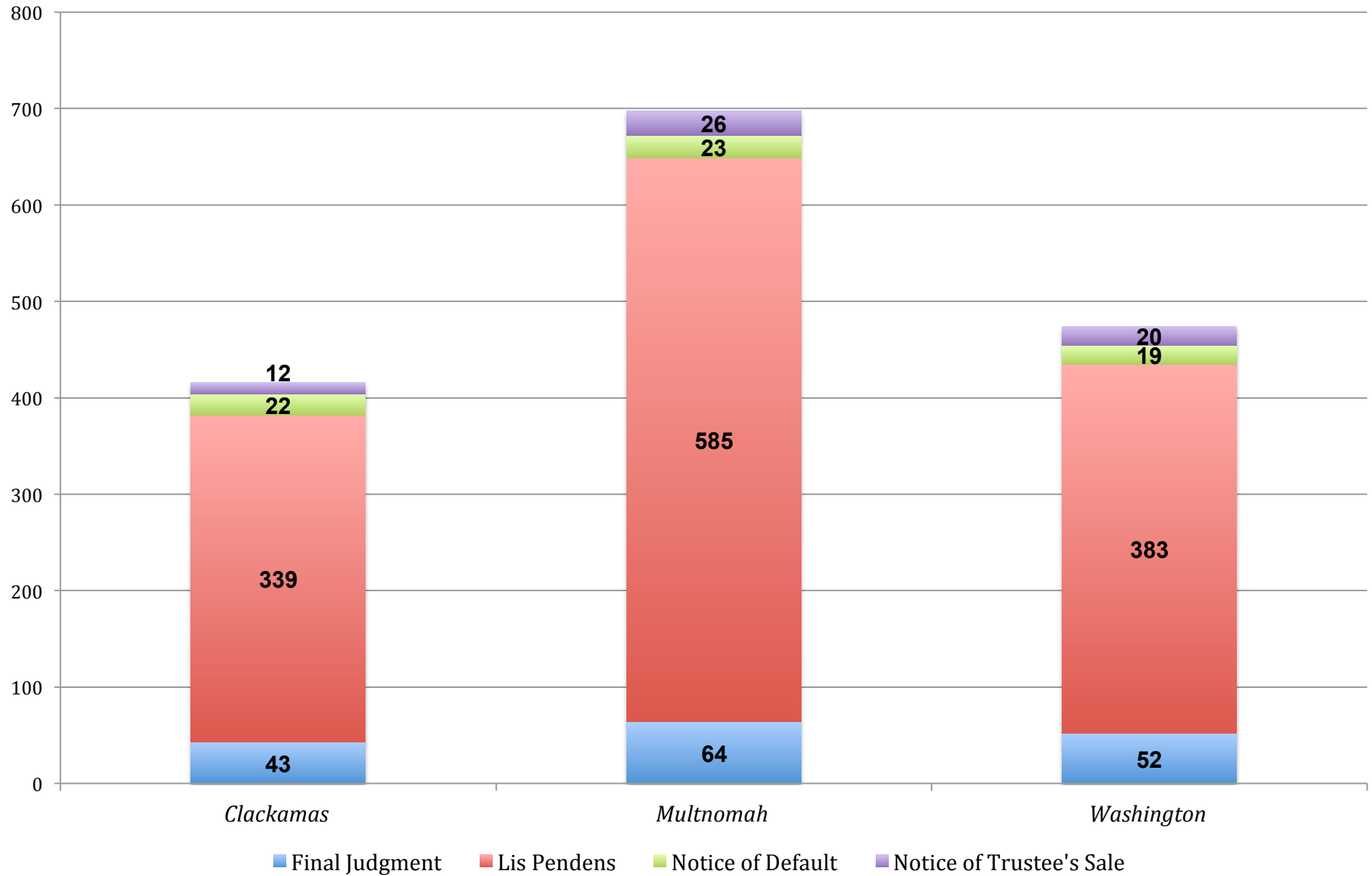

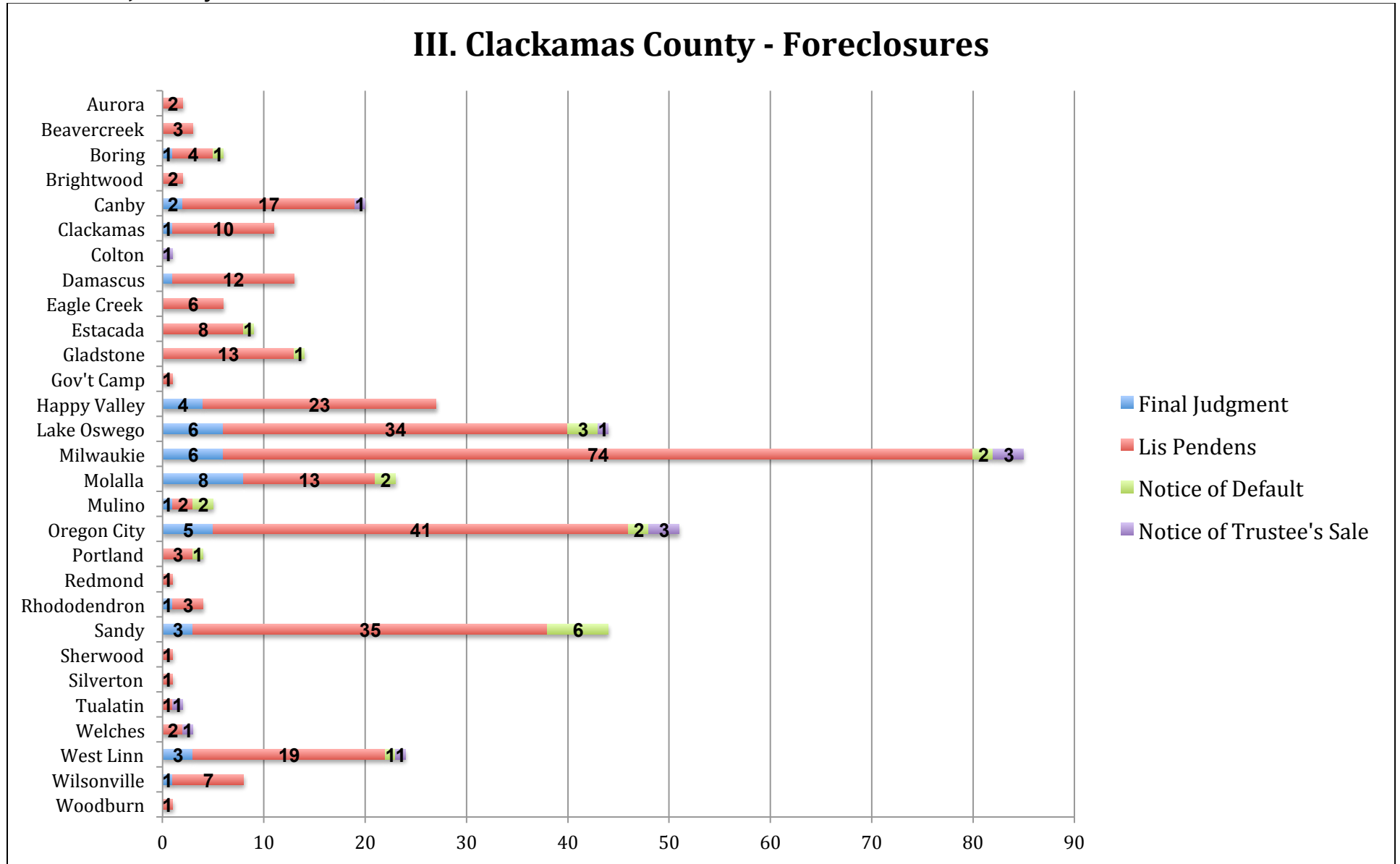
II. Total 1st Quarter County Foreclosures



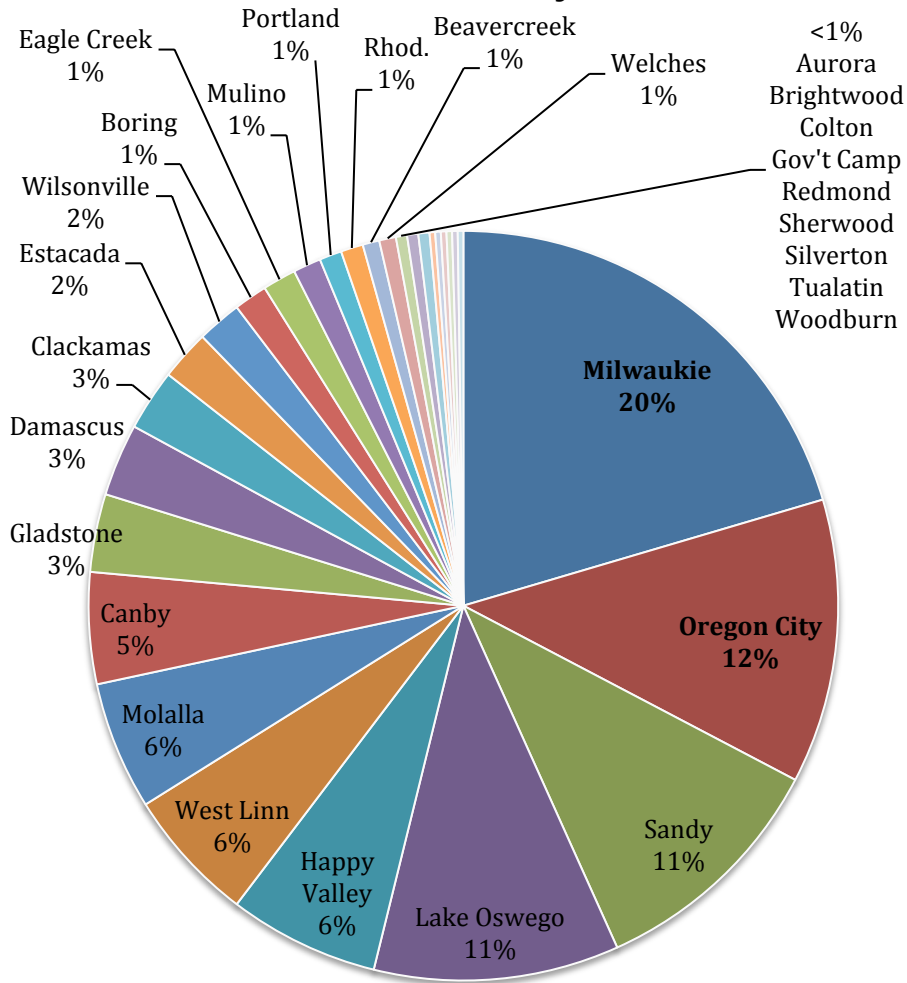

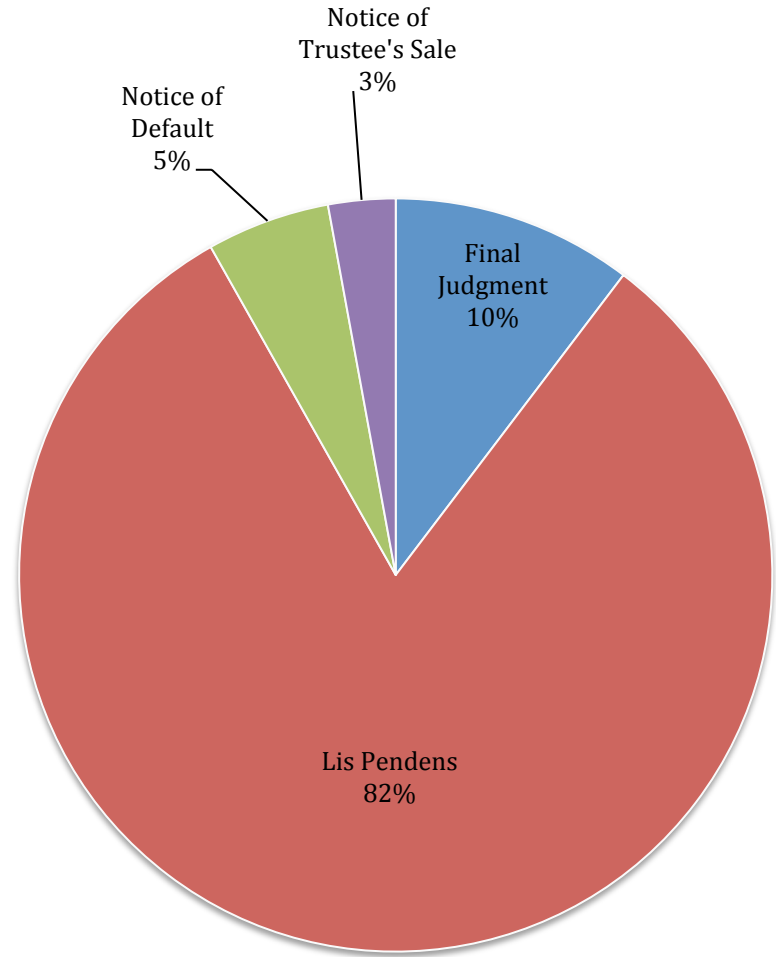

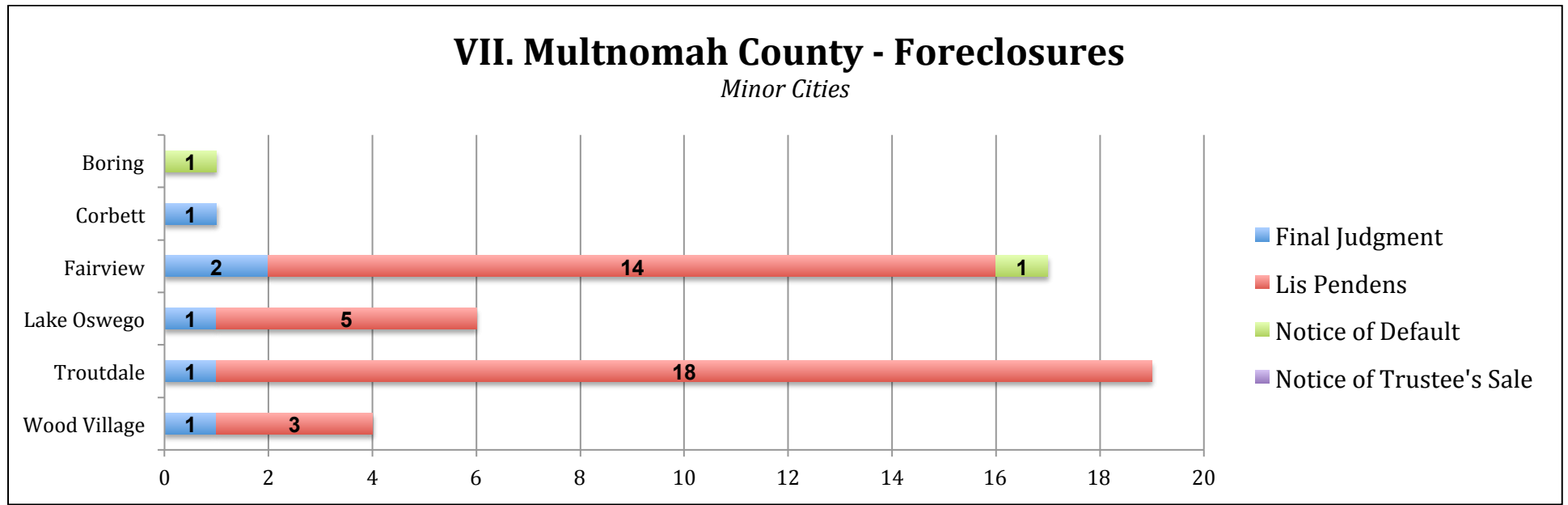
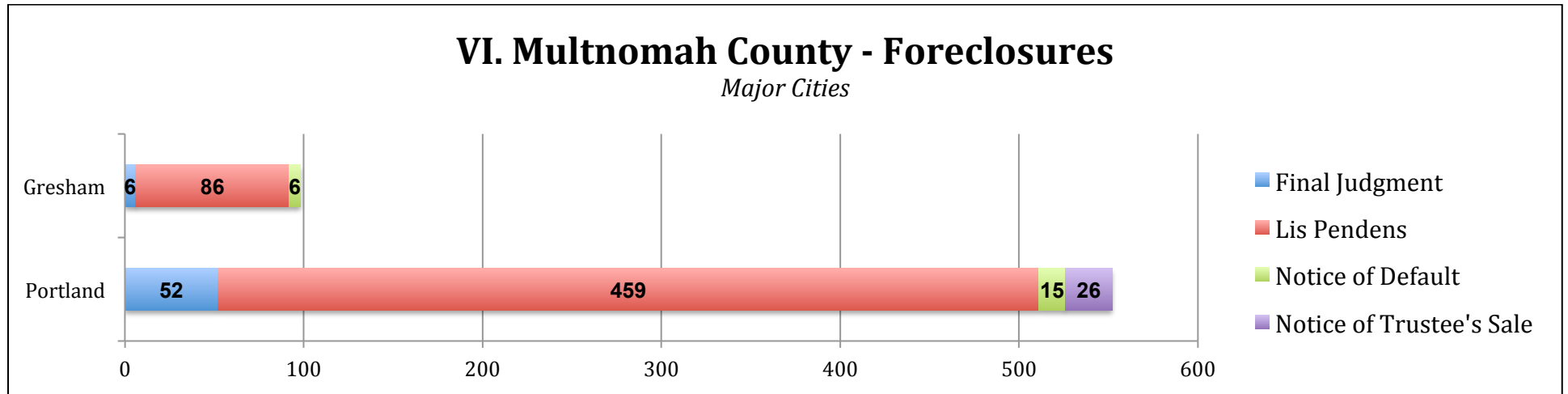
V. Foreclosures by Type



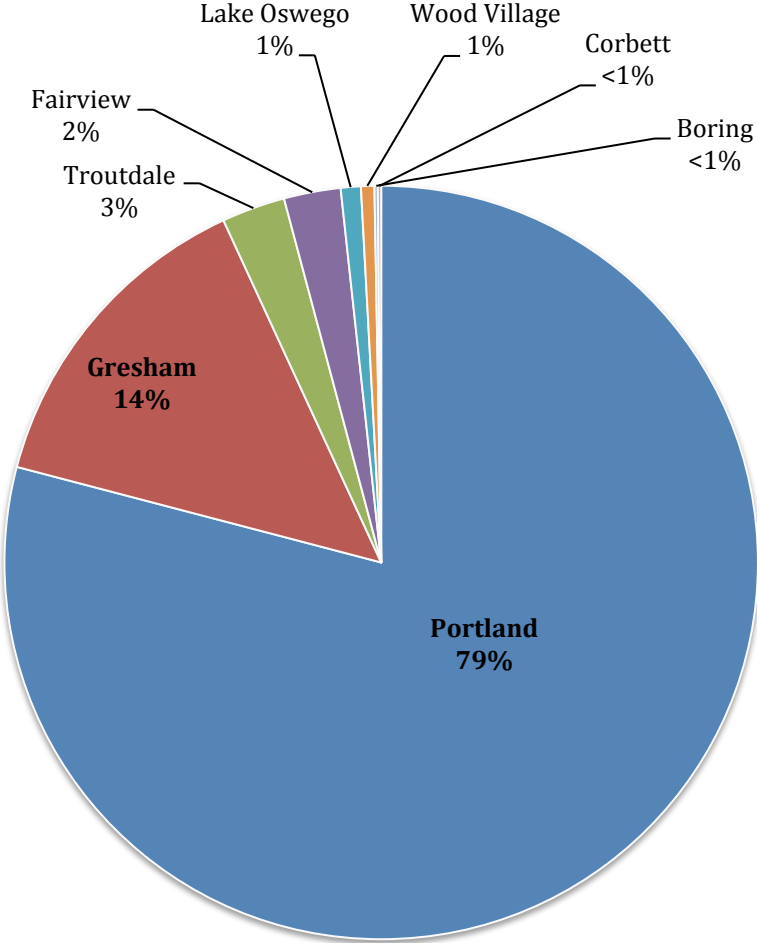

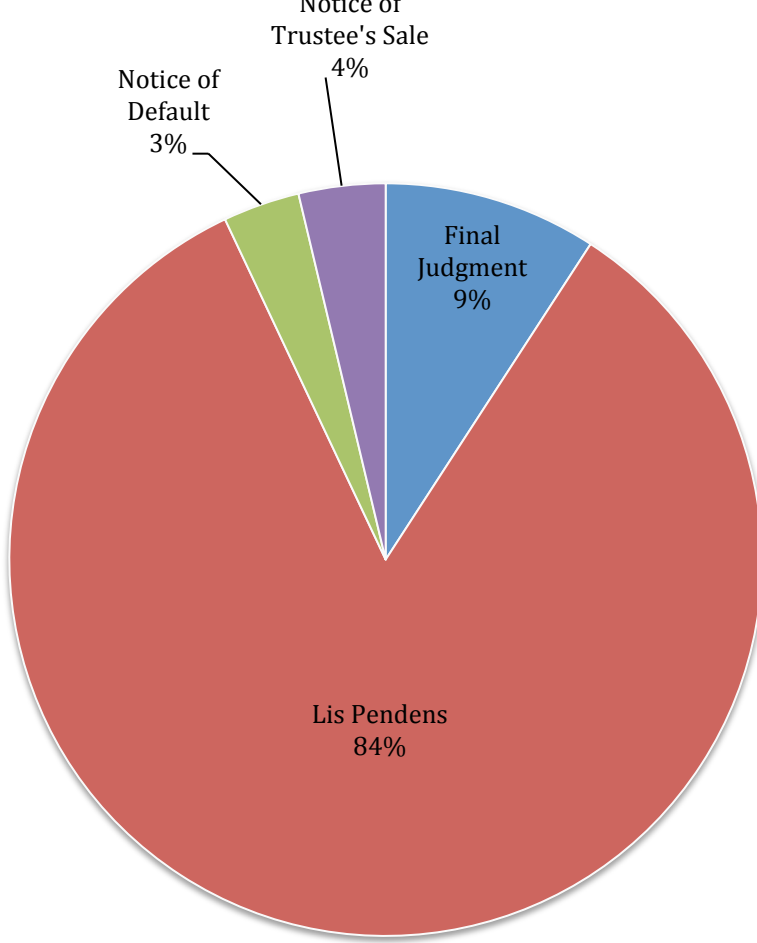

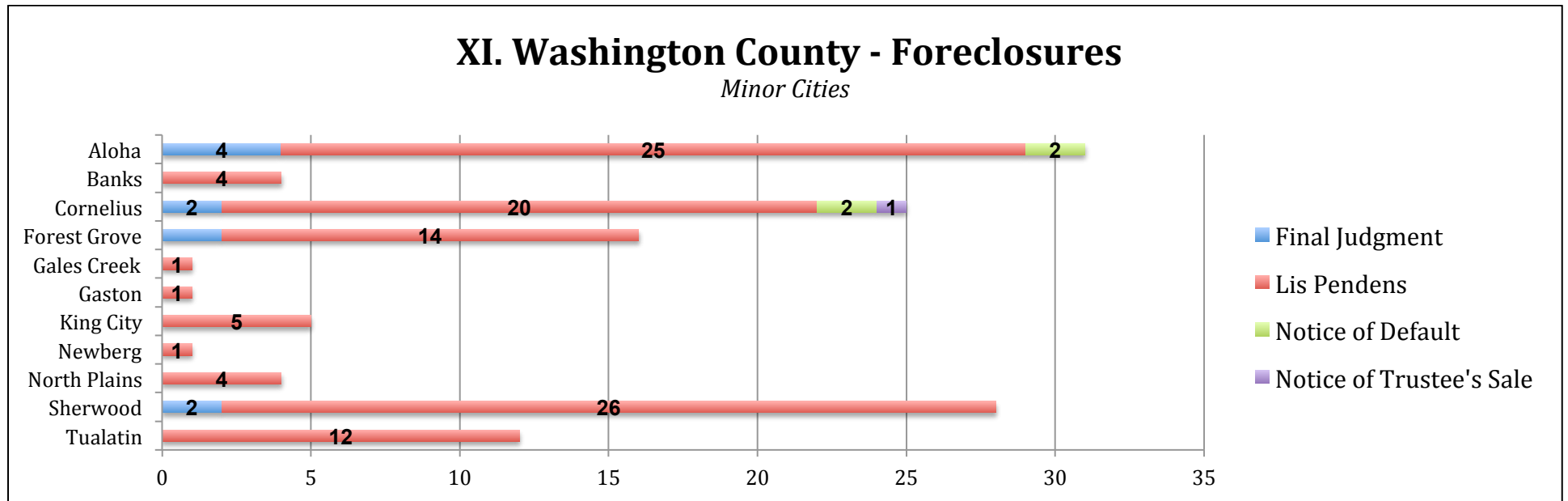
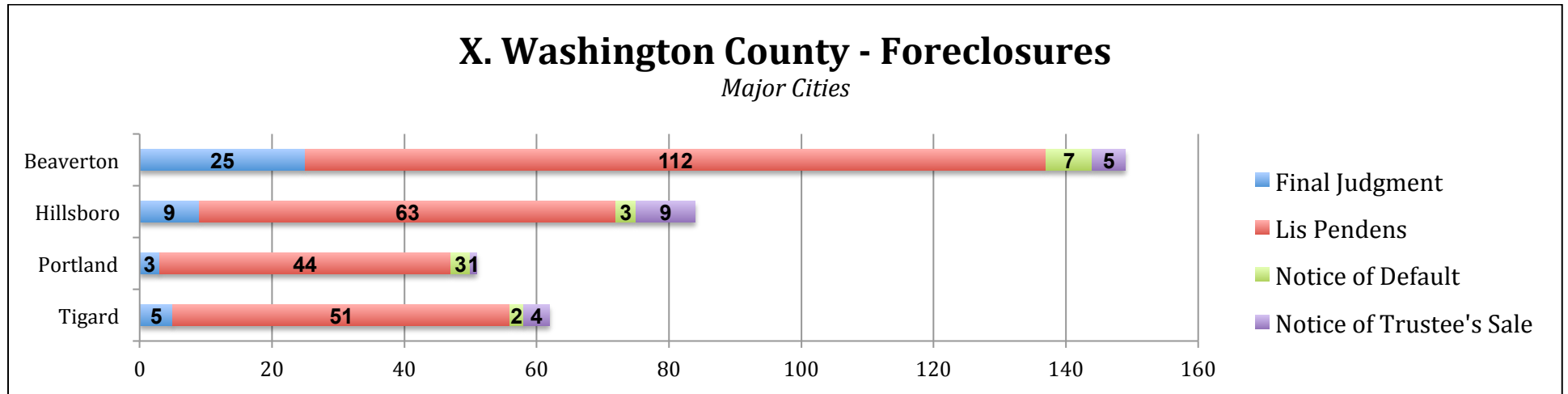

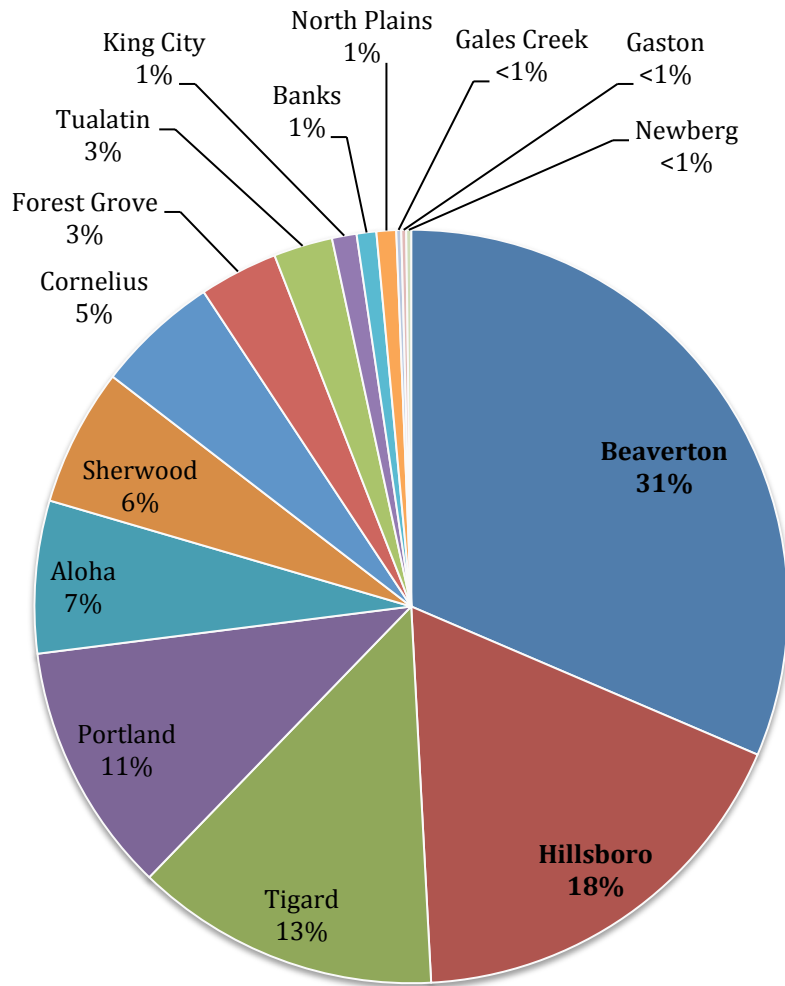
Washington County Foreclosures – 1st Quarter 2013⁴

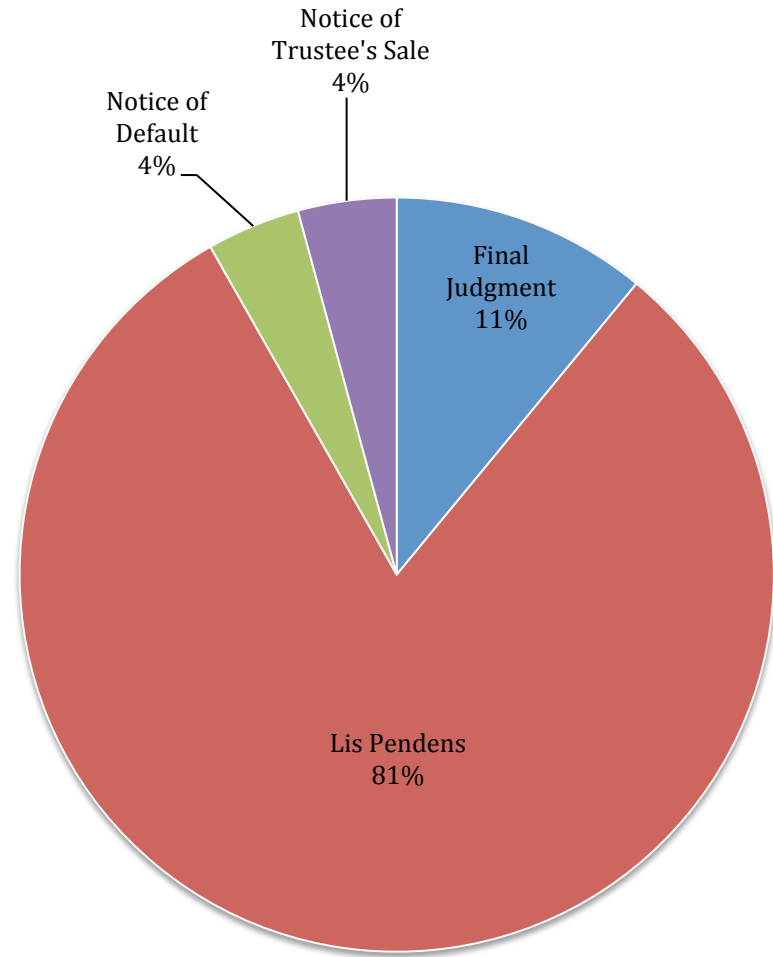
