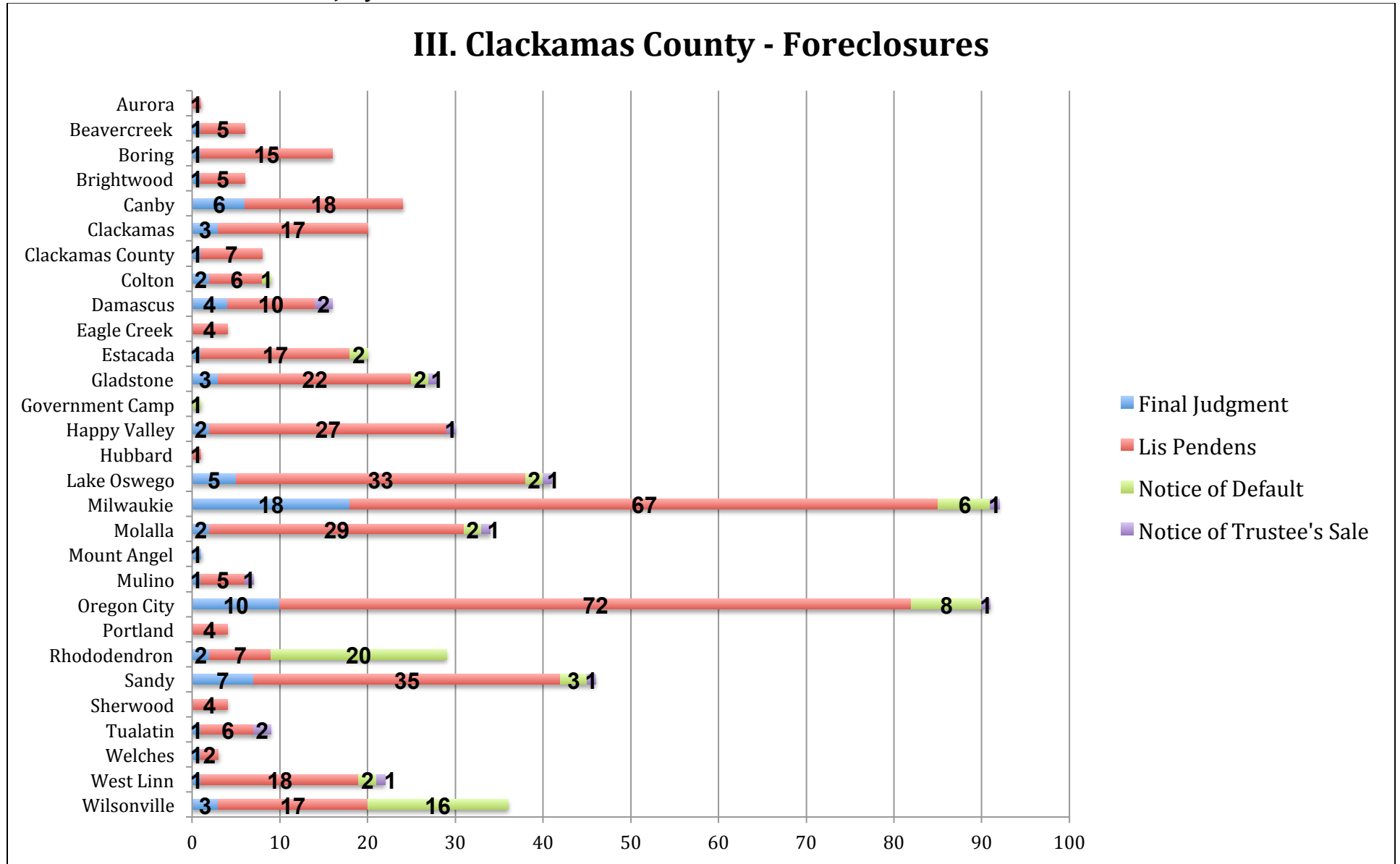

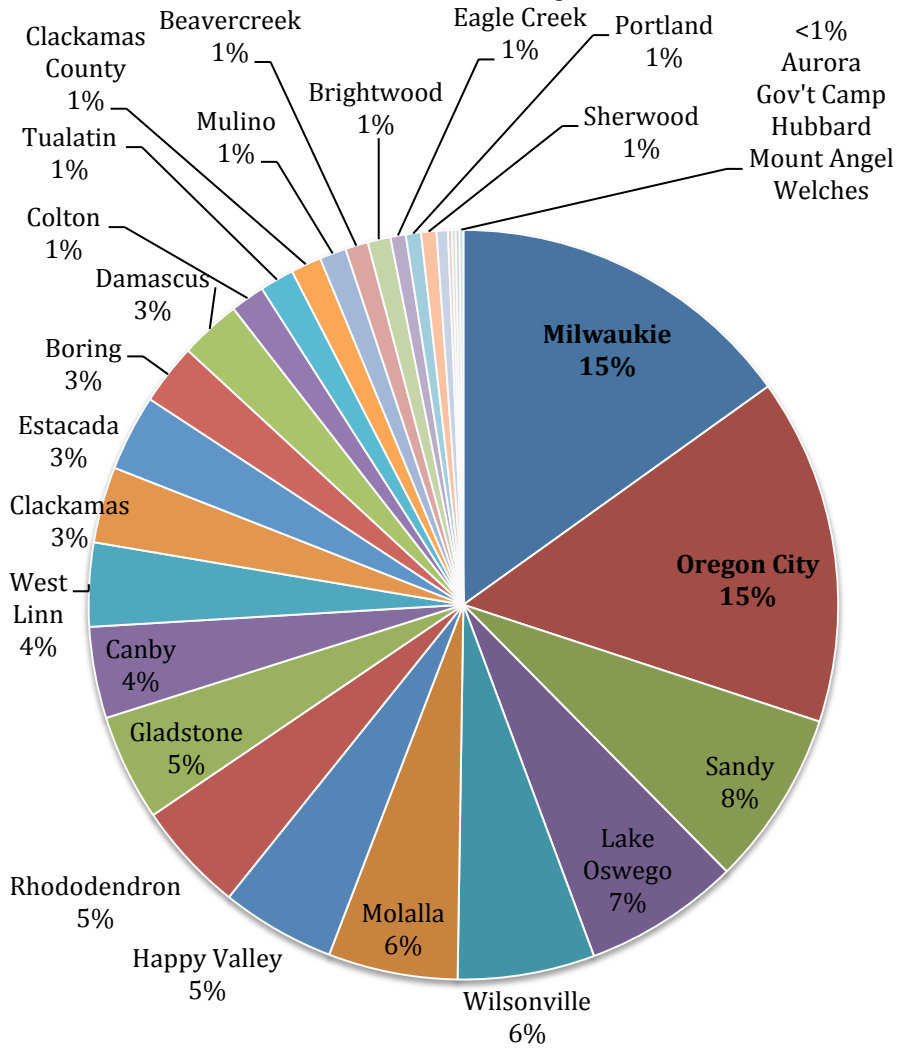

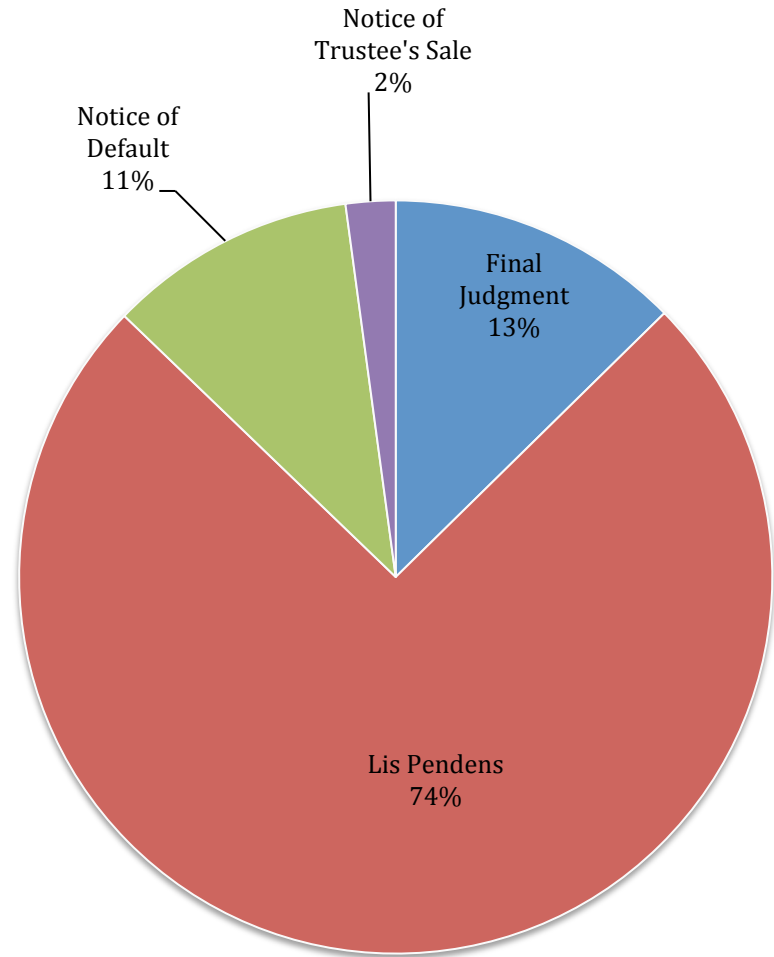

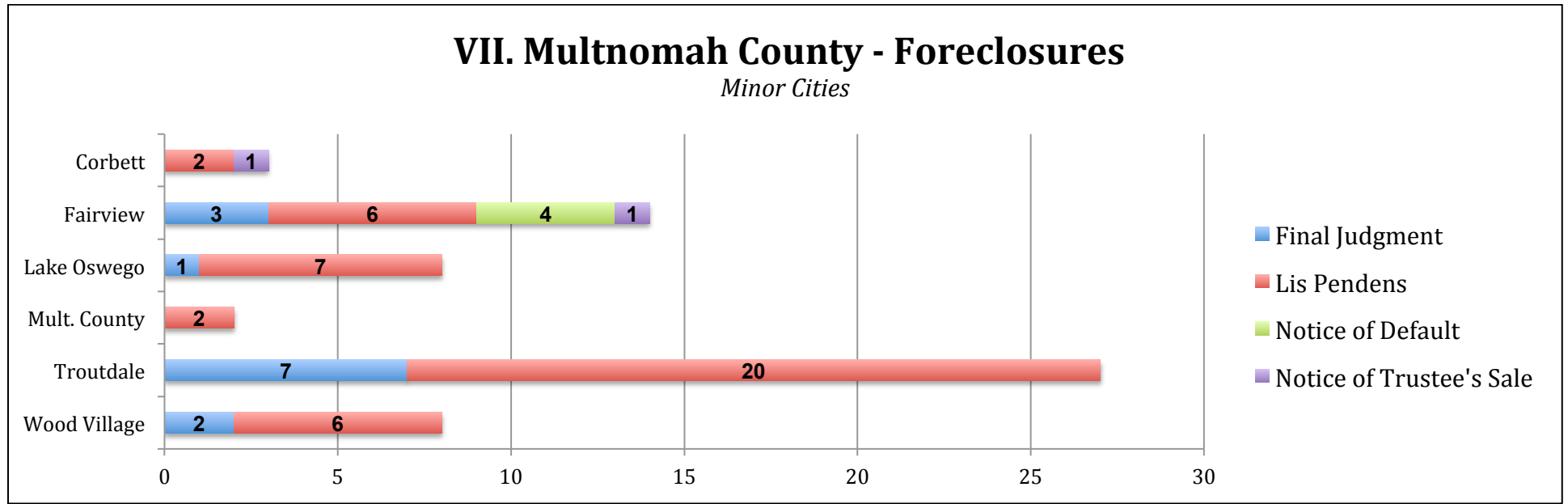

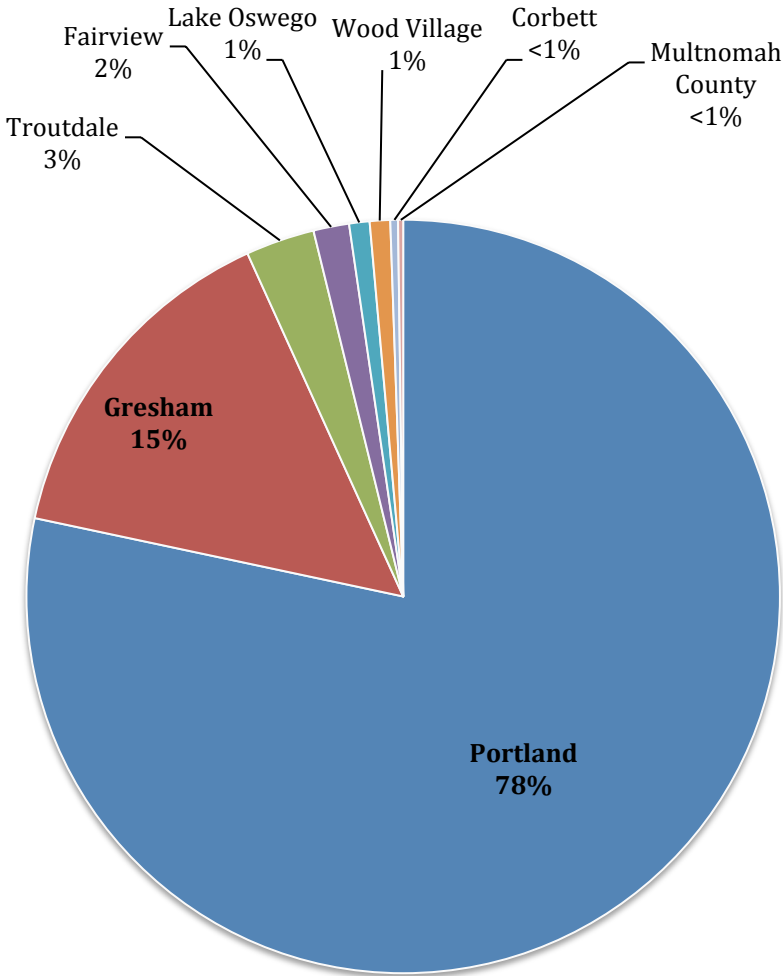

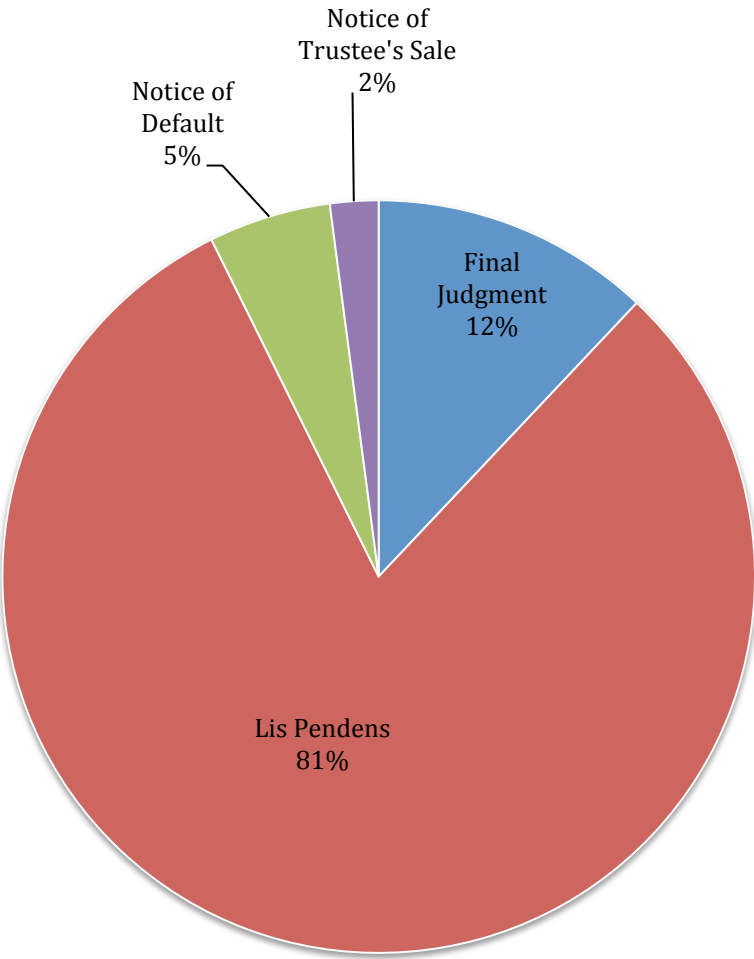

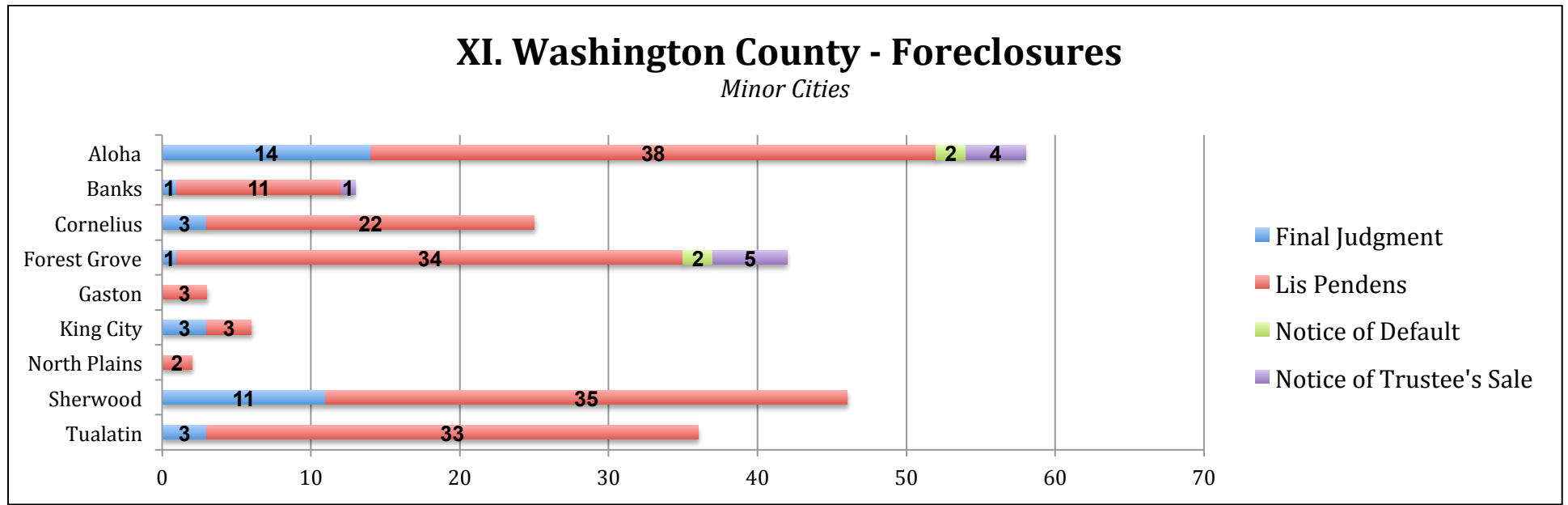

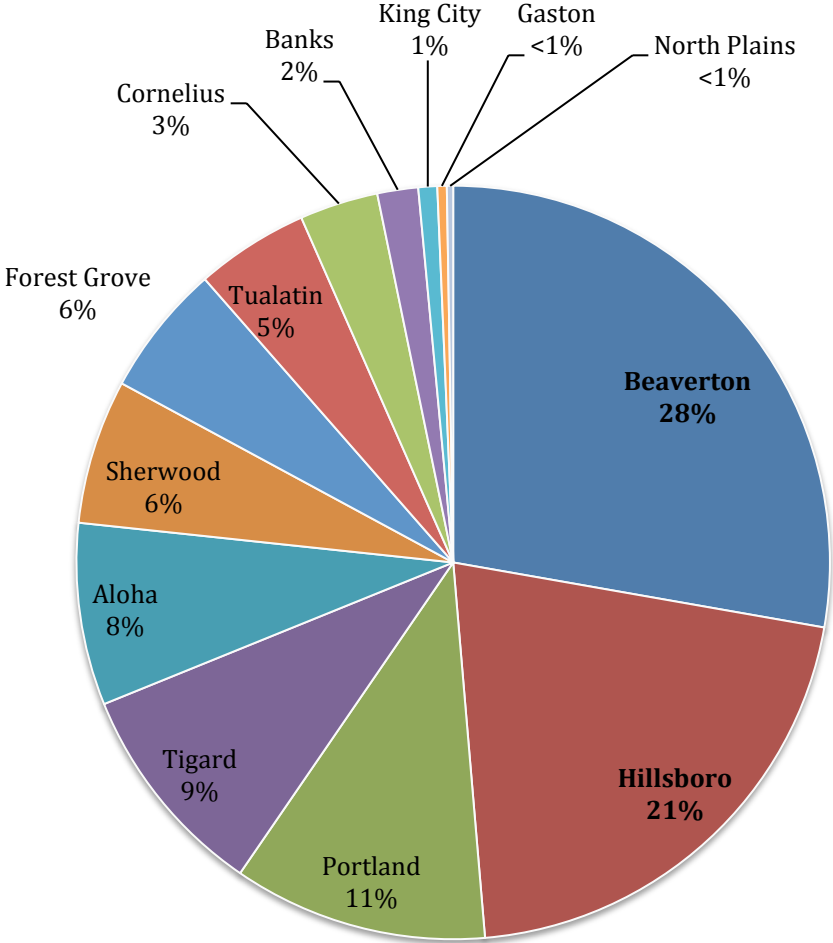
Washington County Foreclosures – 2nd Quarter 2013⁴

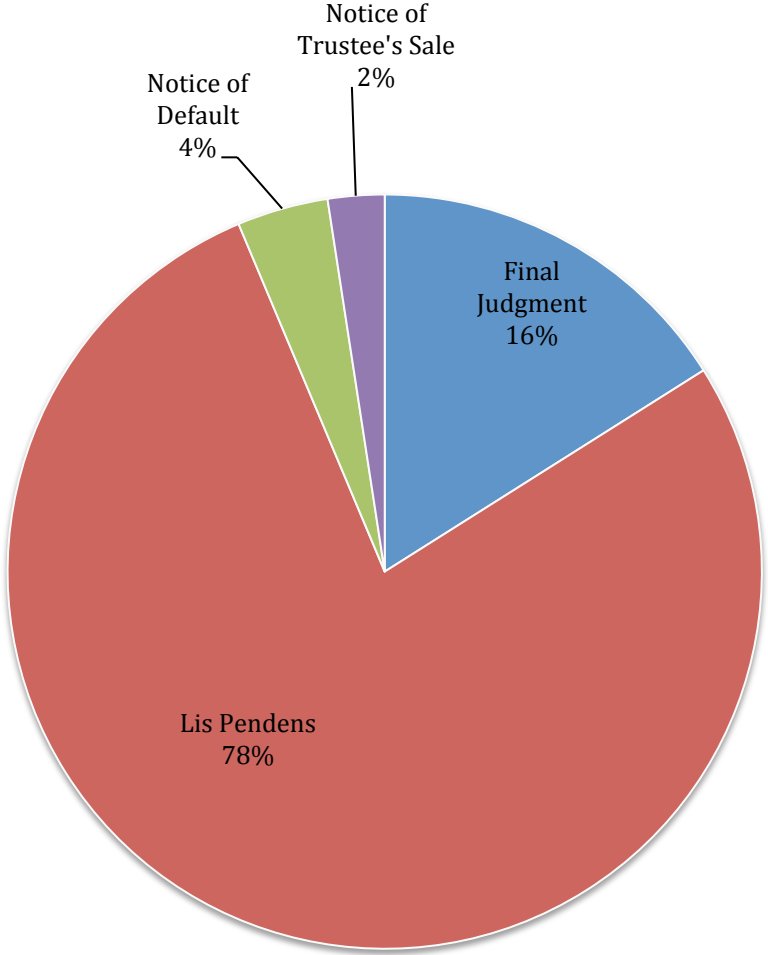
