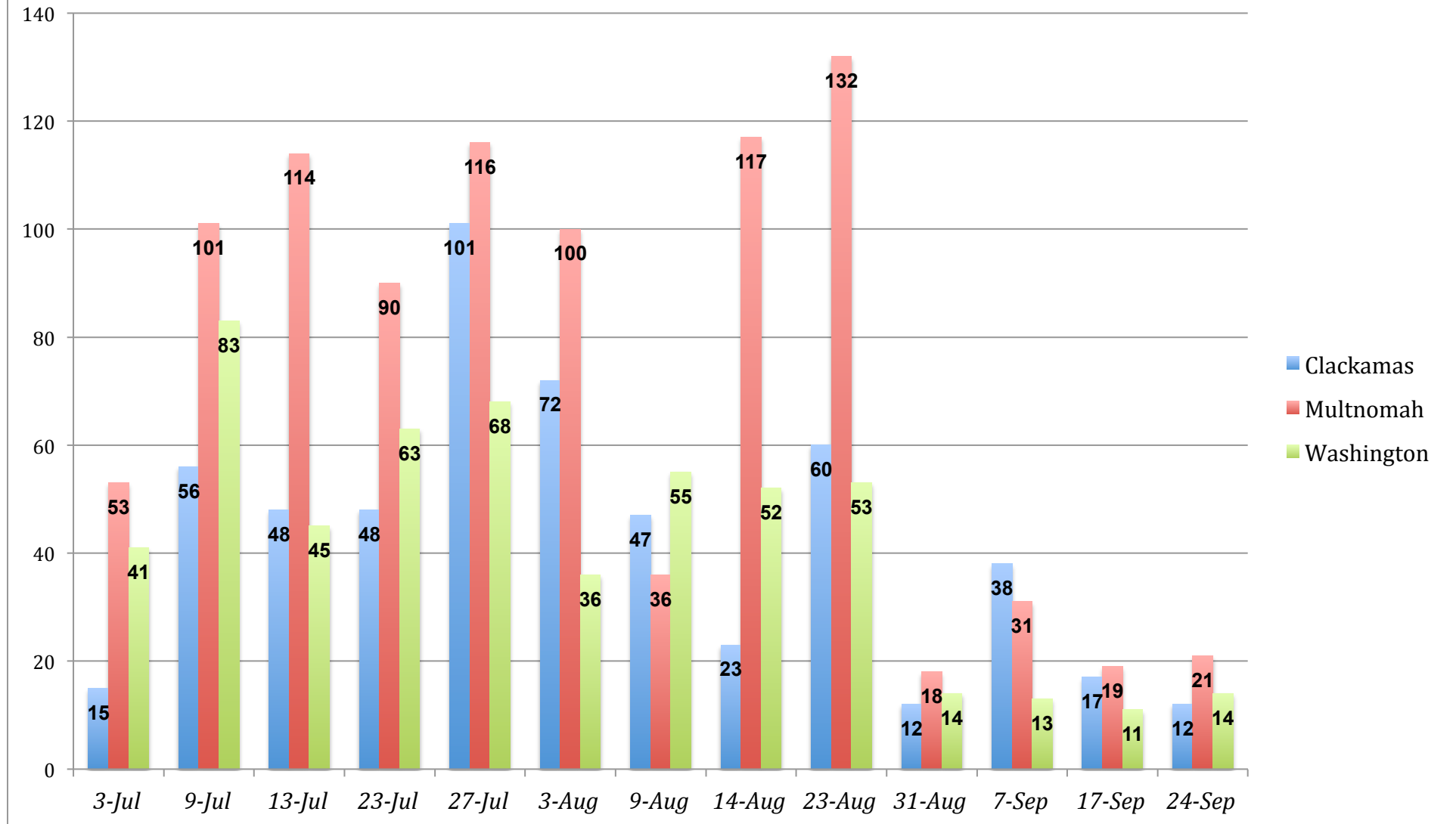


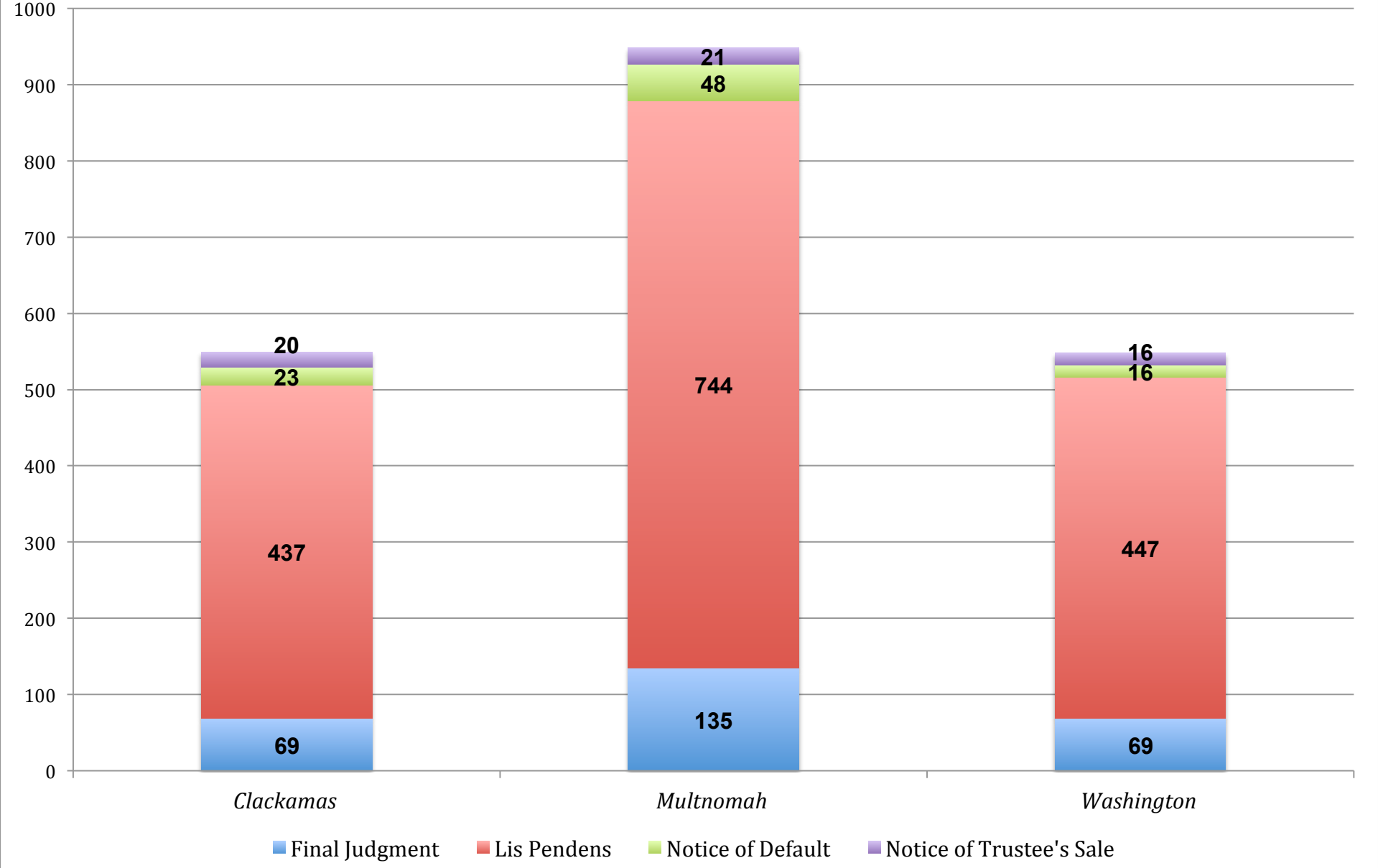

I. Total 3rd Quarter County Foreclosures By Report



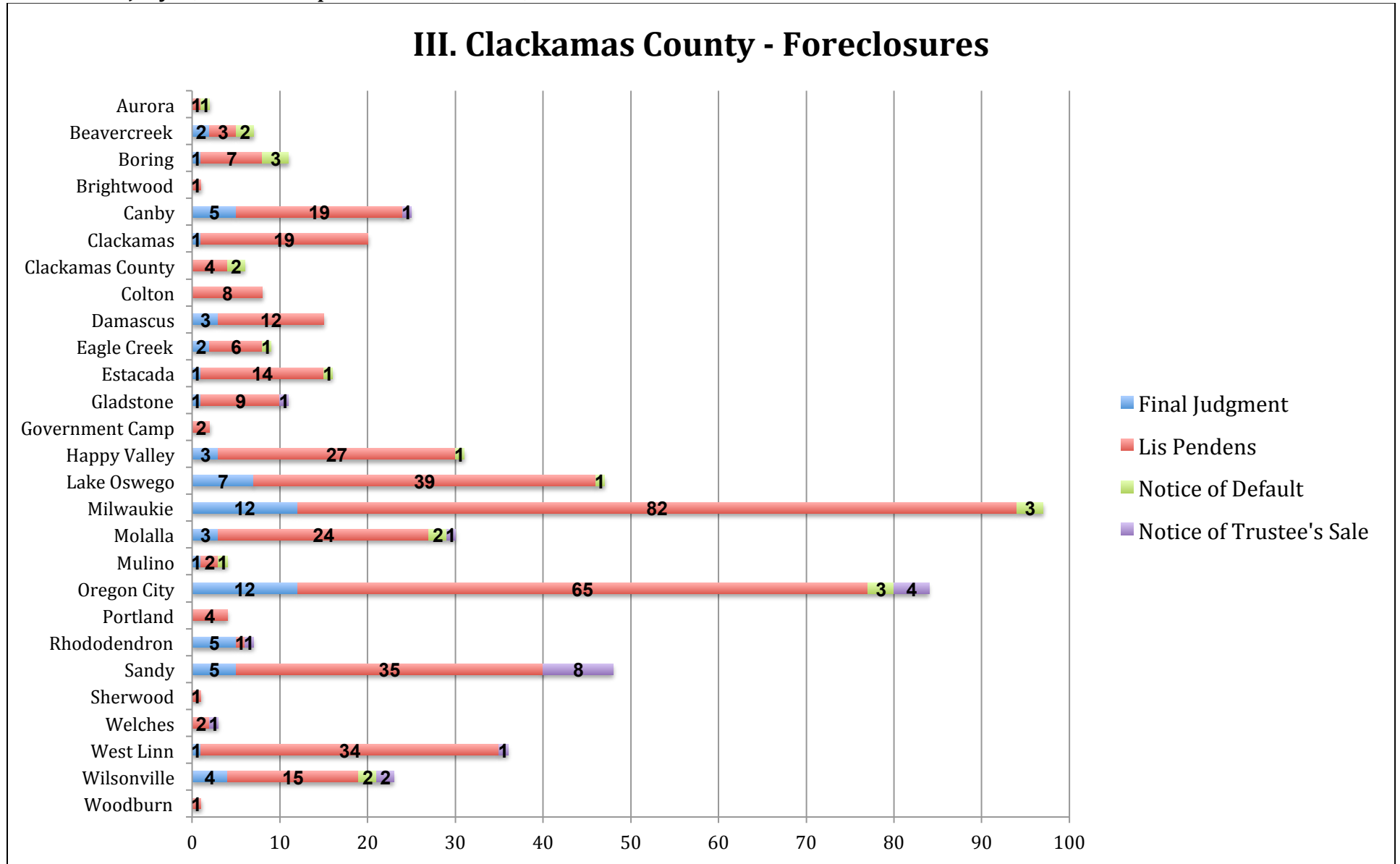

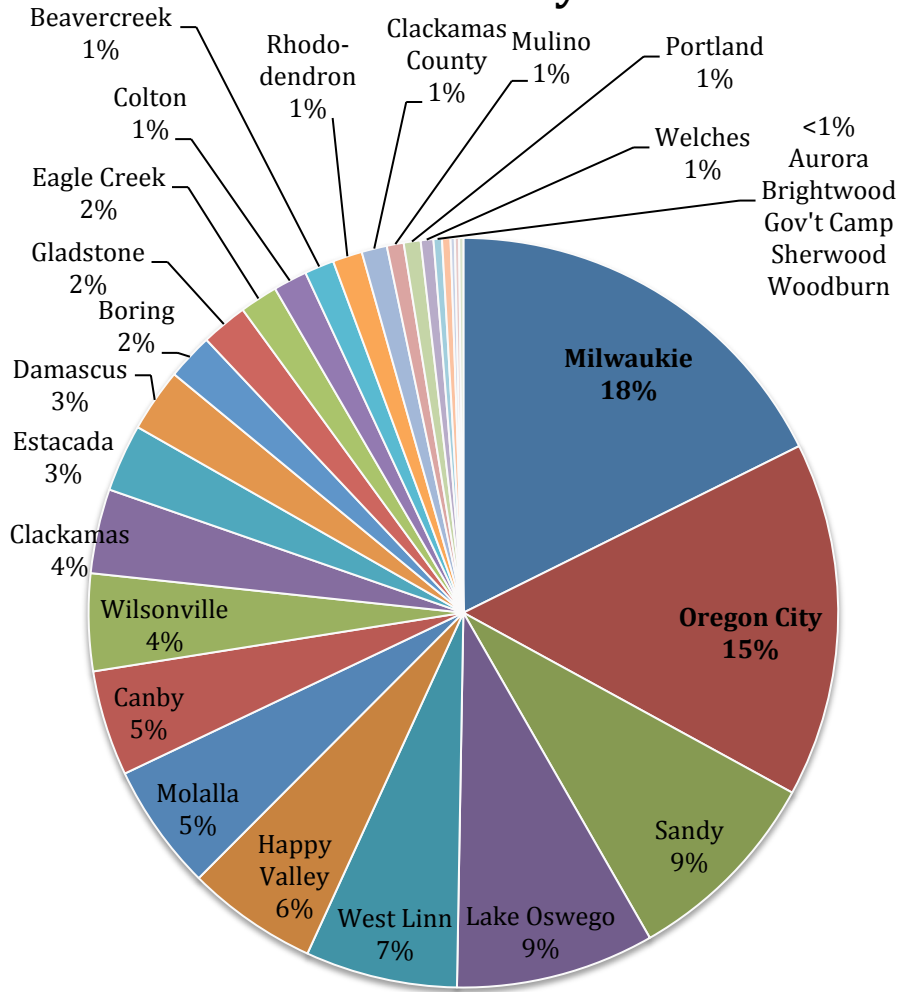

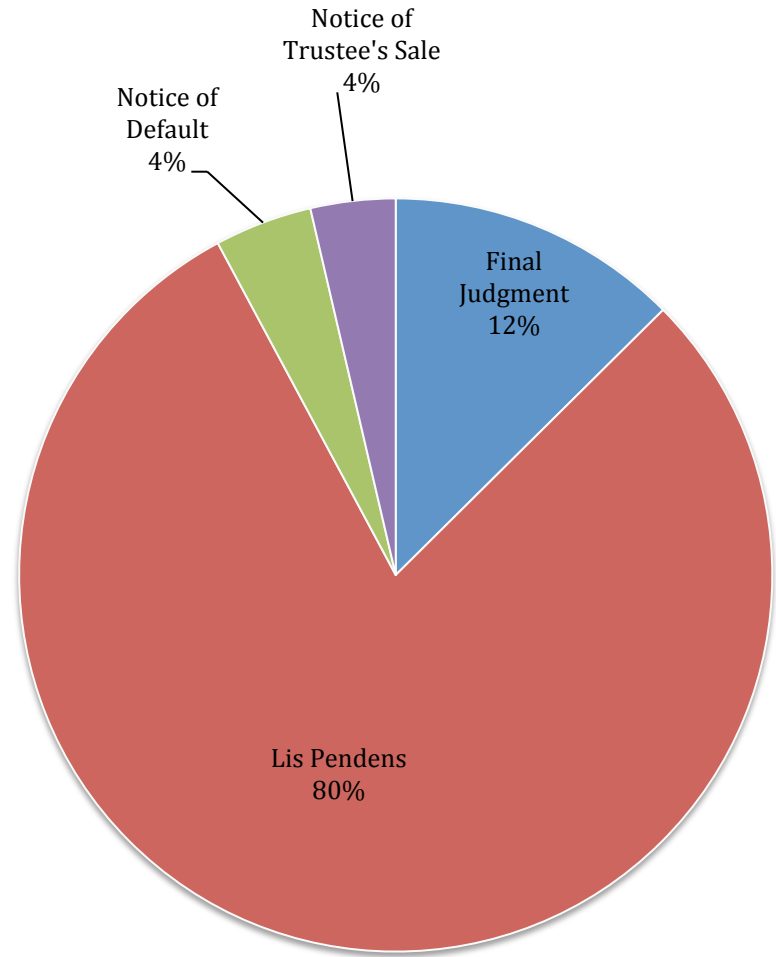

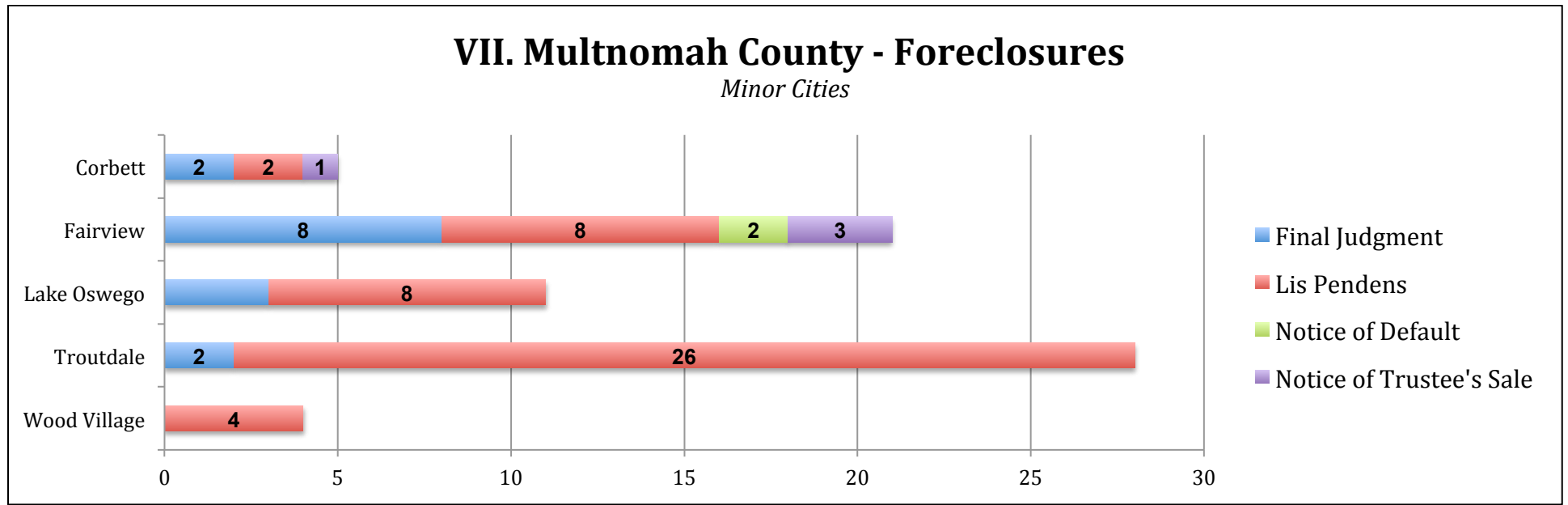

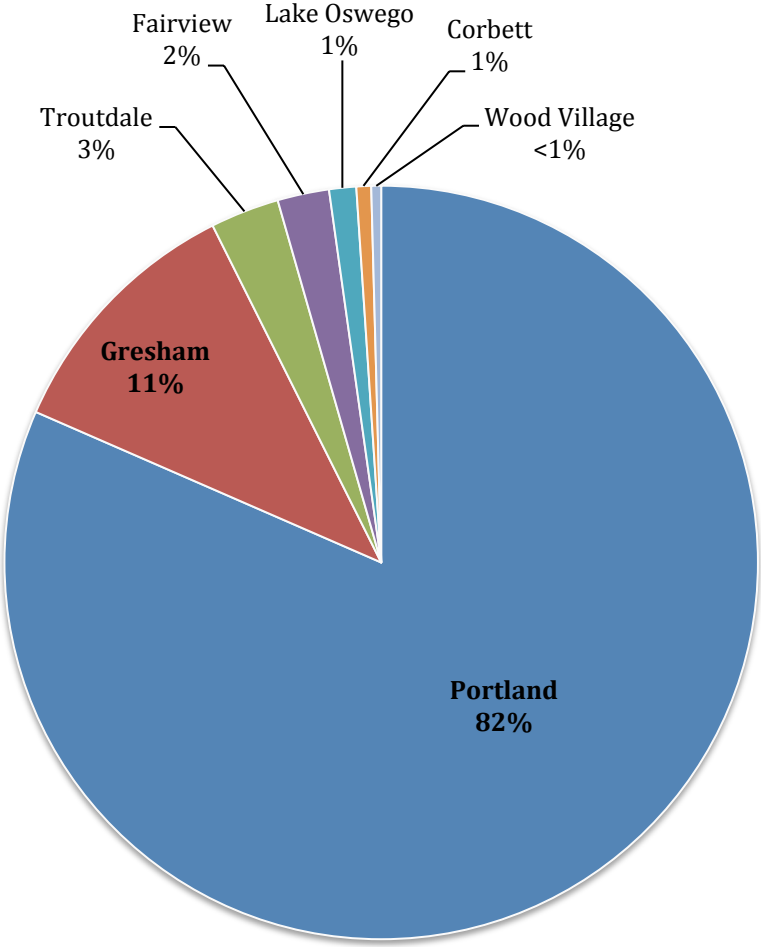

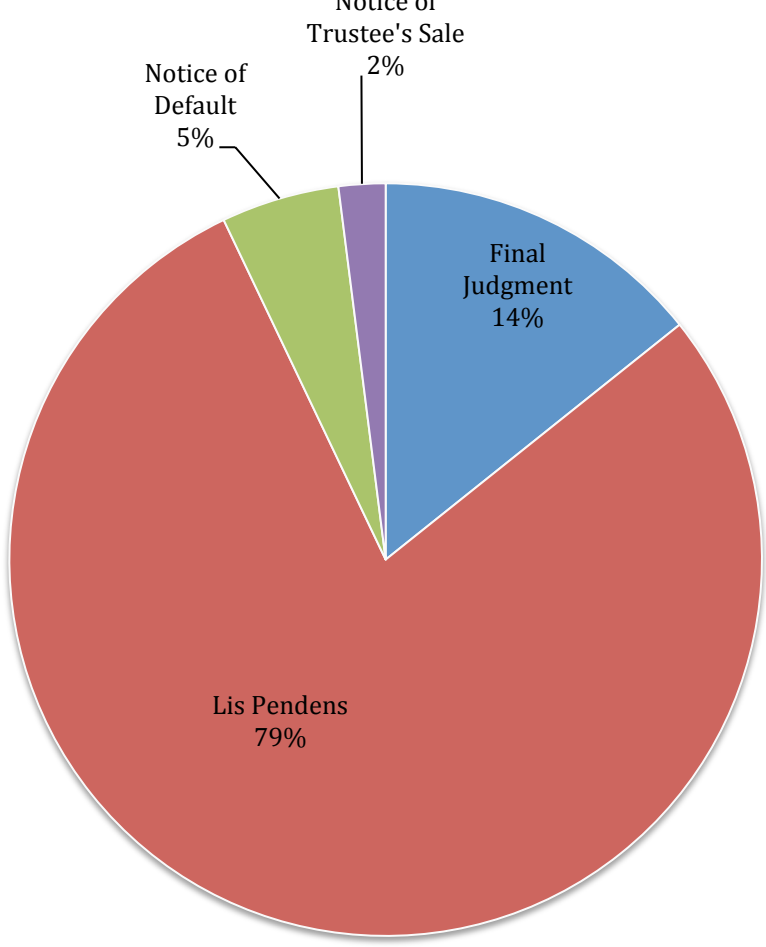

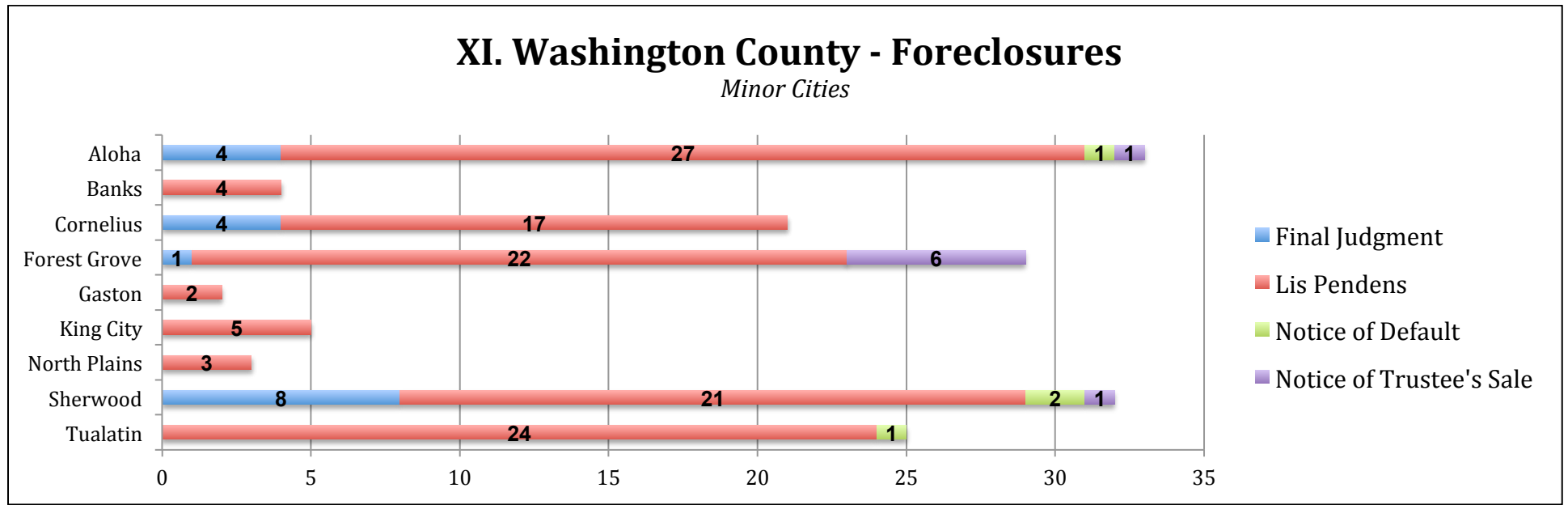

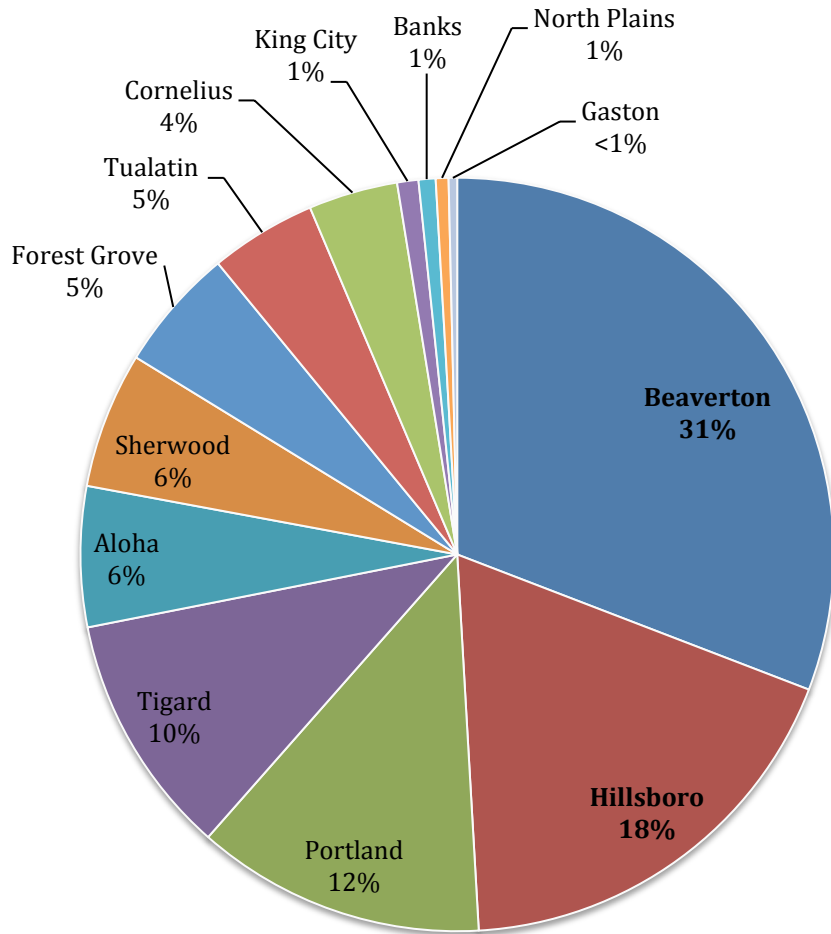
Washington County Foreclosures – 3rd Quarter 2013⁴

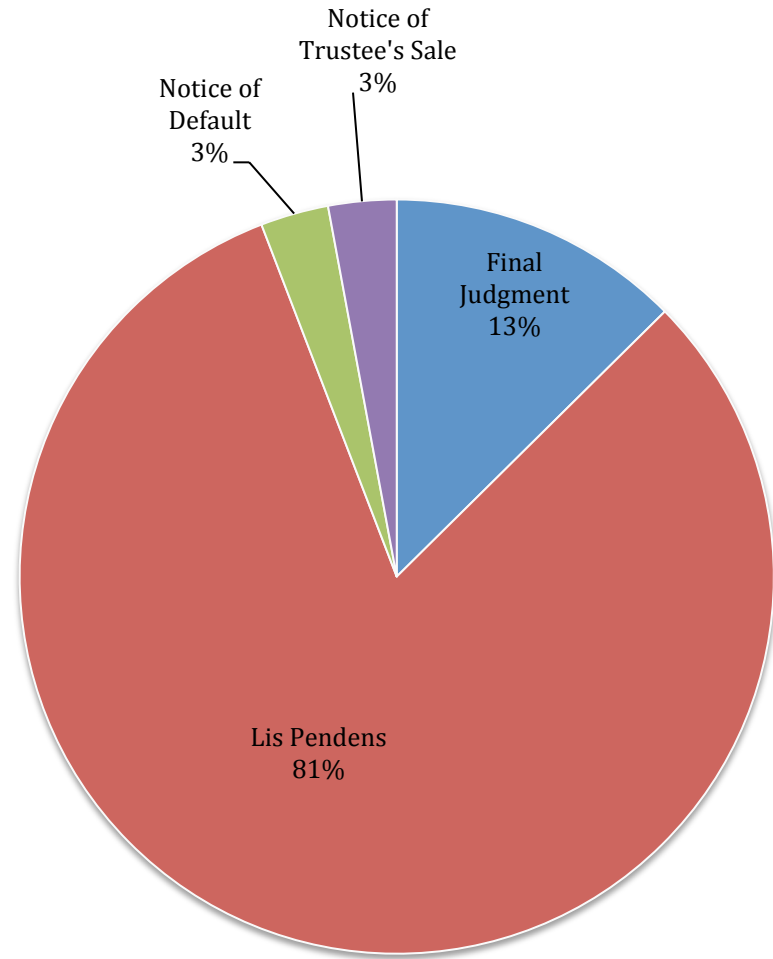
