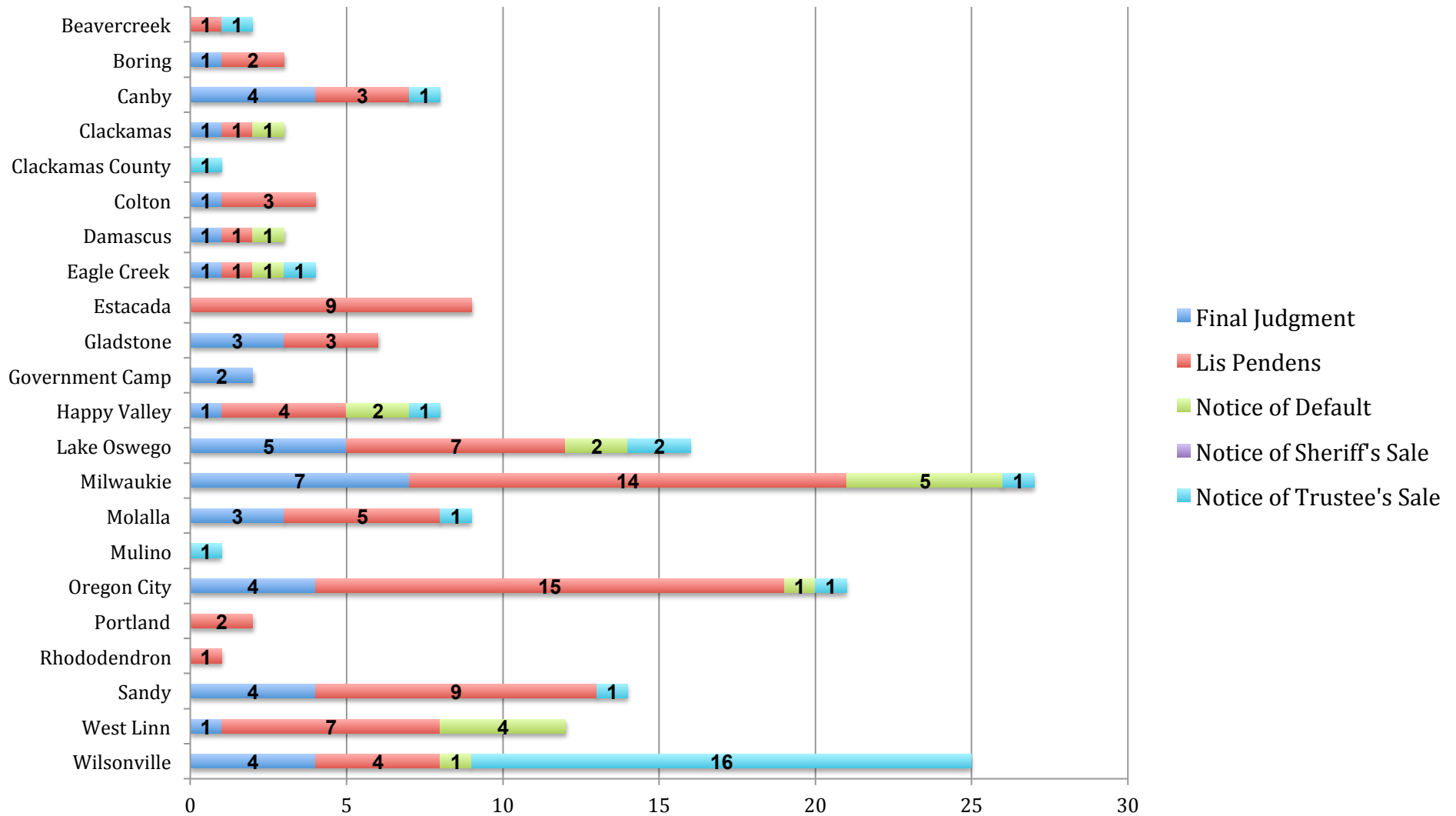

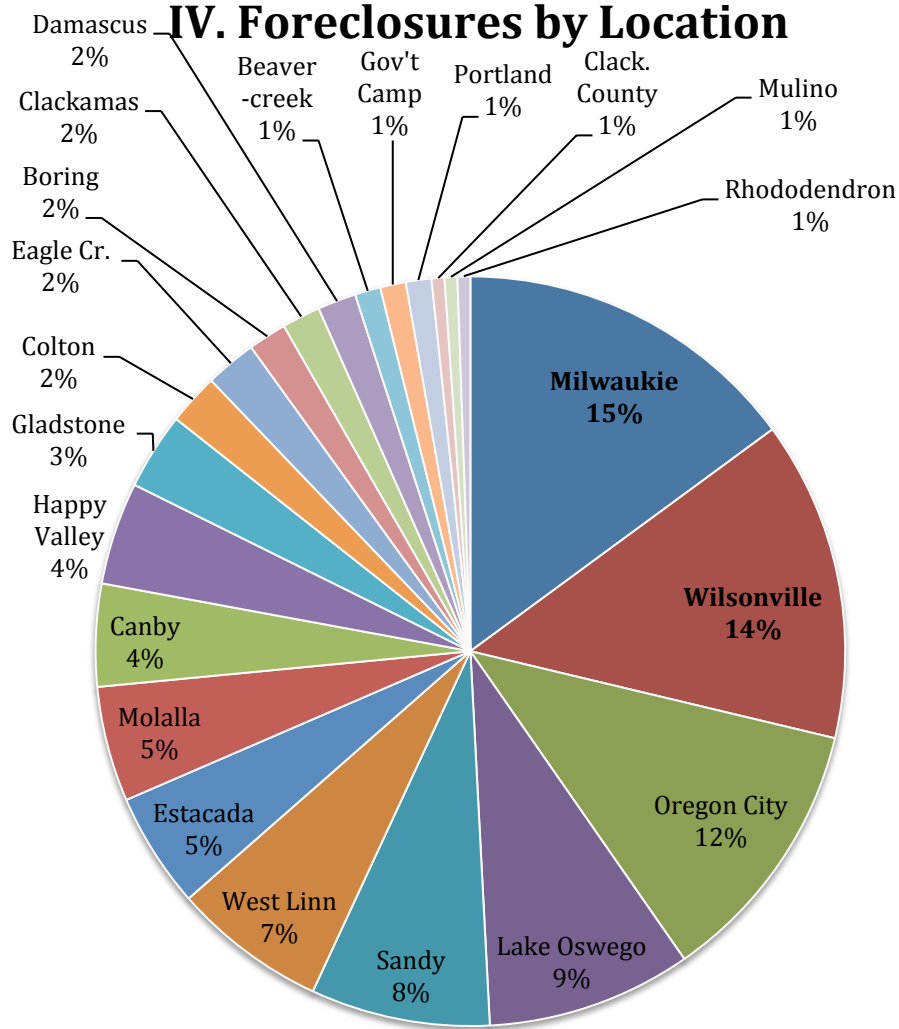

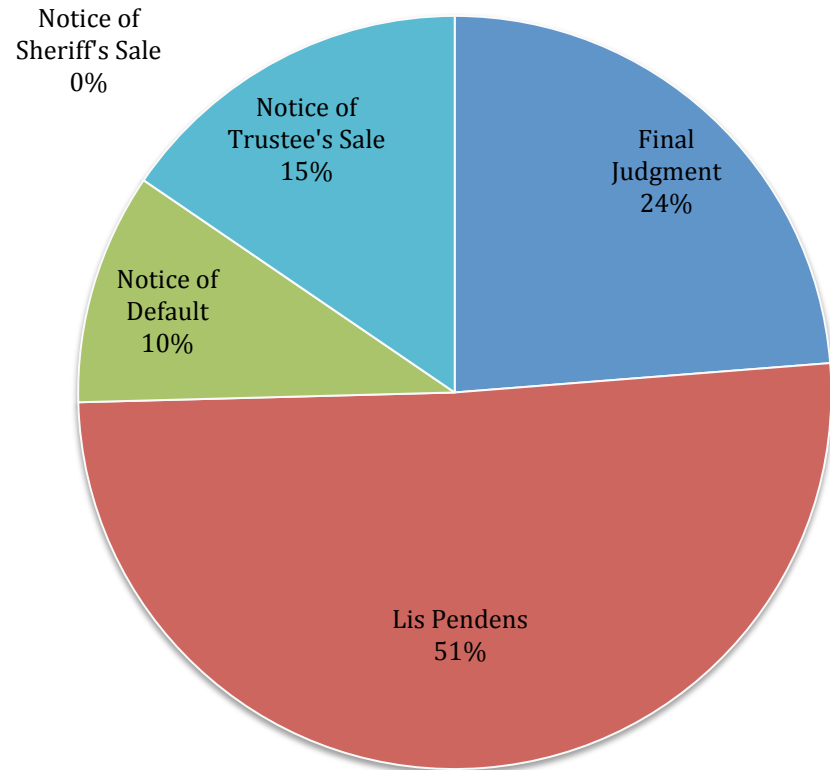
## III. Clackamas County - Foreclosures by Event

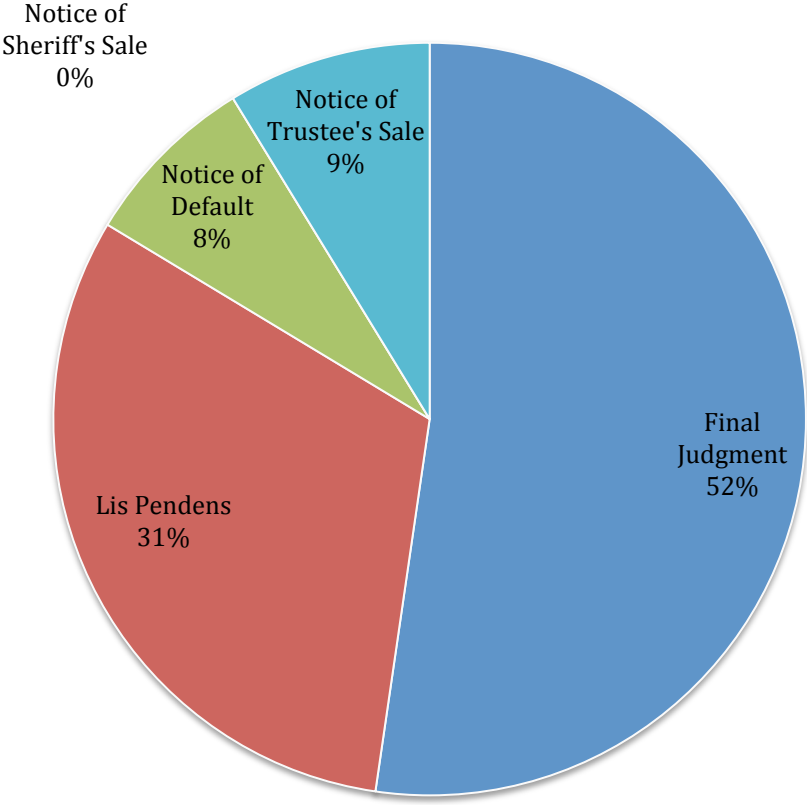

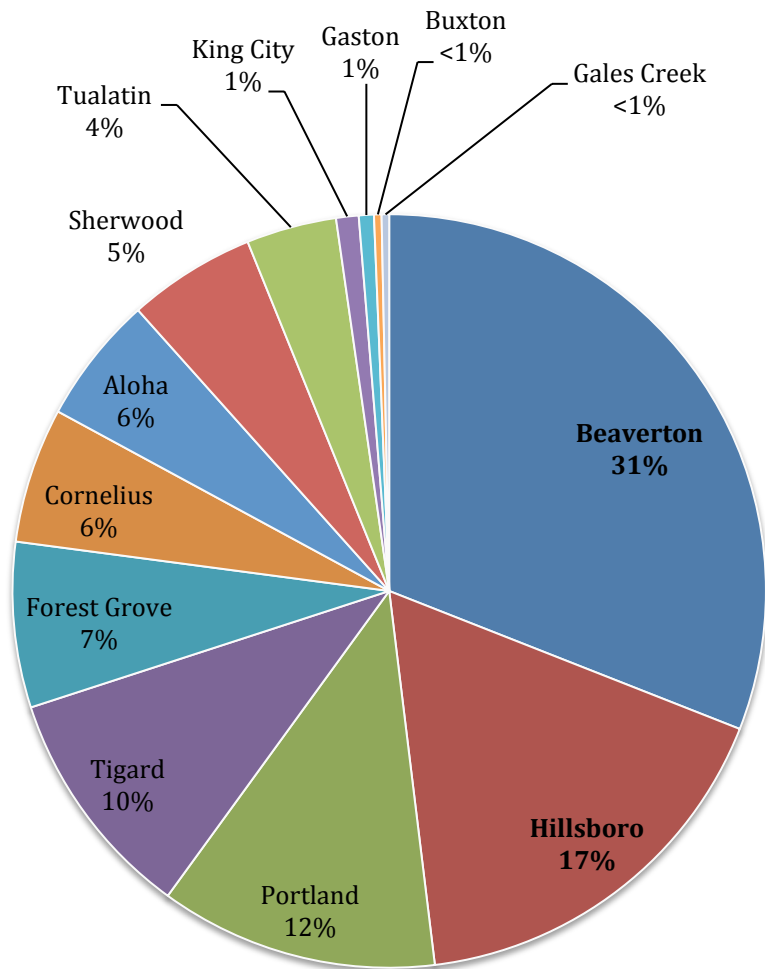
# Washington County Foreclosures – 1st Quarter 2014<sup>4</sup>

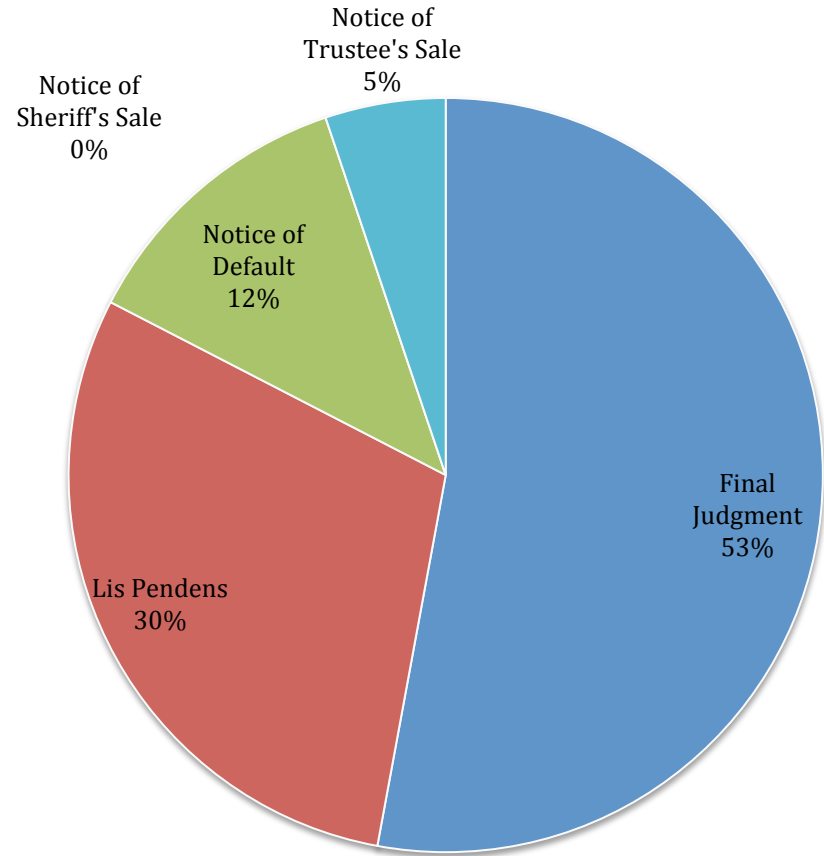
